



## **WD-40 Fan Club Rewards and Prizing Terms and Conditions**

The WD-40® Fan Club Rewards Program from WD-40 Company (“WD-40”, “we” or “us”).

### ***IMPORTANT NOTICE***

We reserve the right to add to and/or change the WD-40 Fan Club Rewards program (“program”) Terms & Conditions at any time. This means, for example, that we may change the number of points earned for spending, or the number of points required to redeem rewards, impose caps on earning and/or redeeming points, and/or cancel rewards. In addition, we reserve the right to terminate the program with three months prior notice. During the three-month notice period, we may change or cancel some or all of the then-current rewards. The WD-40 Fan Club Member’s (“you,” “your,” or “CM”) right to earn points and redeem accumulated points will terminate three months after we give you this notice.

### ***ELIGIBILITY***

1. The program is available to all WD-40 Fan Club members located worldwide.

### ***POINT ACCRUAL***

1. CMs will accrue points for completing activities outlined in Table 1 below.
2. CMs can accrue additional points via Virtual Loyalty Coupons. These coupon codes can be used to award set values of points to specific users during promotions or events.
3. CMs can accrue additional points via Autogenerated Coupon Codes. We reserve the right to implement autogenerated coupon codes.
4. CMs can accrue points by clicking and visiting Bonus Links which may point to a website outside of the WD-40 Fan Club. Bonus Link points can only be redeemed once per day.
5. Points accrued in the WD-40 Fan Club Rewards Program for any given year will be carried forward on each enrollment-date anniversary.
6. Points accrued in any program account do not constitute property of the CM and are not transferable by operation of law or otherwise to any person or entity and cannot be transferred to any other account.
