### 4 – First Aid Measures

<b>Ingestion (Swallowed):</b> While aspiration is unlikely due to viscosity, DO NOT induce vomiting. Call physician, poison control center or the WD-40 Safety Hotline at 1-888-324-7596 immediately.
<b>Eye Contact:</b> Flush thoroughly with water. Get medical attention if irritation persists.
<b>Skin Contact:</b> Wash with soap and water. If irritation develops and persists, get medical attention.
<b>Inhalation (Breathing):</b> If irritation is experienced, move to fresh air. Get medical attention if irritation or other symptoms develop and persist.
<b>Signs and Symptoms of Exposure:</b> May cause mild eye irritation. Prolonged or repeated skin contact may cause mild irritation and defatting dermatitis.
<b>Indication of Immediate Medical Attention/Special Treatment Needed:</b> Immediate medical attention is needed for ingestion.

### 5 – Fire Fighting Measures

<b>Suitable (and unsuitable) Extinguishing Media:</b> Use water fog, dry chemical, carbon dioxide or foam. Do not use water jet or flooding amounts of water. Burning product will float on the surface and spread fire
<b>Specific Hazards Arising from the Chemical:</b> Slightly combustible liquid. If heated above the flashpoint, will release flammable vapors that can present a fire or explosion hazard.
<b>Special Protective Equipment and Precautions for Fire-Fighters:</b> Firefighters should always wear positive pressure self-contained breathing apparatus and full protective clothing in areas where chemicals are used and stored. Cool fire-exposed containers with water.

## 6 – Accidental Release Measures

**Personal Precautions, Protective Equipment and Emergency Procedures:** Wear appropriate protective clothing (see Section 8). Eliminate all sources of ignition and ventilate area.

**Methods and Materials for Containment/Cleanup:** Contain and collect liquid with an inert absorbent and place in a container for disposal. Clean spill area thoroughly. Report spills to authorities as required.

## 7 – Handling and Storage

**Precautions for Safe Handling:** Avoid contact with eyes. Avoid prolonged contact with skin. Avoid breathing oil mists. Use with adequate ventilation. Keep away from heat, hot surfaces and open flames. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep out of the reach of children.

**Conditions for Safe Storage:** Store in a cool, well-ventilated area, away from incompatible materials. NFPA 30 Class IIIB Liquid.

### 10 – Stability and Reactivity

**Ingestion:** This product has low oral toxicity. Swallowing may cause gastrointestinal irritation, nausea, vomiting and diarrhea.

**Carcinogen Status:** None of the components are listed as a carcinogen or suspect carcinogen by IARC, NTP, ACGIH or OSHA.

**Reproductive Toxicity:** None of the components is considered a reproductive hazard.

**Numerical Measures of Toxicity:**

The oral toxicity of this product is estimated to be greater than 5,000 mg/kg and the dermal toxicity greater than 2,000 mg/kg based on an assessment of the ingredients. This product is not classified as toxic by established criteria.
